AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. O-15518 (NEW SERIES), ADOPTED JUNE 8, 1981, INCORPORATING A PORTION OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4, SECTION 1, TOWNSHIP 15 SOUTH, RANGE 3 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE, AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, a request has been received to extend the time on Ordinance No. O-15518 (New Series), adopted June 8, 1981; and

WHEREAS, Section 1 of Ordinance No. O-15518 (New Series) provided that the M-1B Zone would attach if a final map or maps were recorded on or before March 19, 1983; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 0-15518 (New Series), adopted June 8, 1981, is hereby amended to read as follows:

Section 1. That in the event that a portion of the Southeast 1/4 of the Southeast 1/4, Section 1, Township 15 South, Range 3 West, S.B.B.M., in the City of San Diego, California, within the boundary of the district designated "M-1B" on that certain Zone Map Drawing No. B-3179.1, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before March 19, 1986, and

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
