AN ORDINANCE INCORPORATING THE "MISSION GORGE REORGANIZATION NO. 2" INTO COUNCIL DISTRICT NO. 7.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That upon the effective date of the "Mission Gorge Reorganization No. 2," the area which was ordered to be annexed to The City of San Diego by Resolution No. 258862 adopted JUL 11 1983, shall be added to Council District No. 7, which district is shown and delineated on that certain map on file in the office of the City Clerk as Document No. 742458, showing the boundary line of said district, and which map was approved by Ordinance No. 10990 (New Series) of the ordinances of The City of San Diego, adopted February 6, 1973.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
