ORDINANCE NUMBER O- 16016 (New Series)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO PURSUANT TO SECTION 99 OF THE CHARTER OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE A RESTATED STADIUM LEASE FOR THE SAN DIEGO JACK MURPHY STADIUM AND PROVIDING FOR NOTICE AND A PUBLIC HEARING IN CONNECTION THEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. The San Diego Stadium Authority intends to issue additional revenue bonds the proceeds of which will be used to construct certain improvements to the San Diego Jack Murphy Stadium.

Section 2. In order to provide for payment of such bonds and improvements, it is necessary to increase the Base Rental to the City of San Diego under that certain lease agreement between the City of San Diego and the San Diego Stadium Authority entitled "San Diego Stadium Lease," dated as of February 24, 1966 (the "Lease"). To increase said Base Rental, it is necessary to amend the Lease.

Section 3. A Restated Stadium Lease, amending and restating the Lease, in form and substance substantially similar to the form of Restated San Diego Stadium Lease attached hereto is hereby approved.

Section 4. The Mayor of the City of San Diego is hereby authorized to execute said Restated San Diego Stadium Lease on behalf of the City of San Diego, with such additions thereto and

deletions therefrom as the Mayor shall approve.

Section 5. On July 18, 1983, at 2 o'clock p.m., at 202 "C" Street in the City of San Diego, the City Council of the City of San Diego shall hold a public meeting to consider said Restated San Diego Stadium Lease.

Section 6. The Clerk of the City of San Diego is hereby directed to file said Restated San Diego Stadium Lease in the office of the County Recorder after said lease has been executed by all parties thereto.

Section 7. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
