AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16007-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE CITY MANAGER'S DEPARTMENT (0400), ONE (1) MANAGEMENT ASSISTANT TO THE CITY MANAGER (UC) POSITION; ESTABLISHING A SALARY RATE THEREFORE; AND TRANSFERRING THE SUM OF \$36,577 FOR SAID POSITION TO THE GENERAL FUND 100, CITY MANAGER'S DEPARTMENT (0400), FROM THE NEW CONVENTION CENTER FACILITY FUND 10225.

WHEREAS, the San Diego convention center program requires a detailed analysis of the design and operations program and various peripheral matters related to the center; and

WHEREAS, it is necessary to allocate one position to provide the planning, coordination and analytical functions during the peak workload which will be associated with the convention center program; and

WHEREAS, one additional position to provide those services is requested for the City Manager's Department; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," by amending Document No. 00-16007-1, as amended and adopted therein, by adding to the personnel authorization of the City Manager's

Department (0400), one (1) Managament Assistant to the City Manager (UC) position.

Section 2. As a schedule of compensation for the unclassified position created in section 1 above, the salary rate set forth in Salary Range 02.0 of the Table of Classifications and Standard Salary Rates, identified as Exhibit C to Ordinance No. O-15976 (New Series), be and the same is hereby adopted.

Section 3. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$36,577 from the New Convention Center Facility Fund 10225 to the General Fund 100, City Manager's Department (0400) to provide the money necessary to fund the above created position.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
