AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0506, RELATING TO CONDITIONAL USE PERMITS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 101.0506 to read as follows:

SEC. 101.0506 CONDITIONAL USE PERMIT
GRANTED BY PLANNING COMMISSION

A. USES WHICH MAY BE CONSIDERED

The Planning Commission shall have the authority under conditions herein provided to permit by Conditional Use Permit the following uses in any zone, including interim zones, except as otherwise provided in paragraphs "A.l.,"

"A.2.," "A.6.," "A.12.," and "A.14." of this section:

- 1. 5. no change.
- 6. Fraternity houses, sorority houses and student dormitories provided that such use is within an area designated for such use in the applicable community plan or, if no such area is designated, is within one mile of the exterior boundaries of the campus of a major institution of higher learning and is in the R-3, R-3A, R-4 or R-4C zones.
 - 7. 15. no change.

B. - G. no change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
