AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16007-1 AND NO. OO-16007-2, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING FROM THE COUNCIL ADMINISTRATION DIVISION (029) AND ADDING TO THE PERSONNEL AUTHORIZATION OF THE OFFICE OF THE MAYOR (010) ONE (1.00) SENIOR COMMITTEE CONSULTANT AND ONE (1.00) ADMINISTRATIVE SECRETARY POSITION; TRANSFERRING WITHIN THE GENERAL FUND 100, THE SUM OF \$82,297 FROM THE COUNCIL ADMINISTRATION DIVISION (029) TO THE MAYOR'S OFFICE (010), FOR THE PURPOSE OF PROVIDING PERSONNEL AND RELATED NON-PERSONNEL FUNDS FOR THE ABOVE POSITIONS.

WHEREAS, on September 12, 1983, the City Council adopted Ordinance No. O-16032, a series of changes to the Permanent Rules of Council (Municipal Code section 22.0101); and

WHEREAS, these changes, included in Ordinance No. O-16032, included restoring the position of Senior Committee Consultant and Administrative Secretary to the office of the Mayor, transferring those positions from the Committee Consultant Activity of the Council Administration Division (029); and

WHEREAS, it is now necessary and appropriate to amend the annual appropriation ordinance to reflect such transfer and also transfer the personnel and related non-personnel funds associated therewith; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. O-16007 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16007-1 and No. OO-16007-2, as amended and adopted therein, by transferring from the Council Administration Division (029) and adding to the Personnel Authorization of the Mayor's office (010) one (1.00) Senior Committee Consultant and one (1.00) Administrative Secretary position.

Section 2. That the Auditor and Comptroller is hereby authorized to transfer within the General Fund 100, the sum of \$82,297 from the Council Administration Division (029) to the Mayor's office (010) for the purpose of providing personnel and related non-personnel funds for the above authorization.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of the City of San Diego.

OO-18007-2, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING FROM THE COUNCIL ADMINISTRATION DIVISION (029) AND ADDING TO THE PERSONNEL AUTHORIZATION OF THE OFFICE OF THE MAYOR (010) ONE (1.00) SENIOR COMMITTEE CONSULTANT AND ONE (1.00) ADMINISTRATIVE SECRETARY POSITION; TRANSFERRING WITHIN THE GENERAL FUND 100, THE SUM OF \$82,297 FROM THE COUNCIL ADMINISTRATION DIVISION (029) TO THE MAYOR'S OFFICE (010), FOR THE PURPOSE OF PROVIDING PERSONNEL AND RELATED NON-PERSONNEL FUNDS FOR THE ABOVE POSITIONS.

The City Council amended the Permanent Rules of Council to restore the Rules Committee Consultant and an Administrative Secretary to the Mayor's budget. This ordinance amends the budget to transfer those two positions from the Council Administration Division (029) to the Mayor's office (010) and transfers concurrently the sum of \$82,297 which represents Personnel and related non-personnel funds for the two positions.
