ORDINANCE NUMBER O-16057 (New Series)

Adopted on OCT 10 1983

AN ORDINANCE INCORPORATING LOTS 35 THROUGH 48, BLOCK 51, CITY HEIGHTS, MAP NO. 1007 (APPROXIMATELY 1.12 ACRES), IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CC ZONE, AS DEFINED BY SECTION 101.0427 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13057 (ADOPTED DECEMBER 22, 1930), AND ORDINANCE NO. 9350 (NEW SERIES), ADOPTED JANUARY 20, 1966, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Lots 35 through 48, Block 51, City Heights, Map No. 1007 (approximately 1.12 acres), in the City of San Diego, California, within the boundary of the district designated "CC" on Zone Map Drawing No. B-3592, filed in the office of the City Clerk as Document No. 768745, be, and they are hereby incorporated into CC Zone, as such zone is described and defined by Section 101.0427 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13057, adopted December 22, 1930, and Ordinance No. 9350 (New Series), adopted January 20, 1966, of the ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
