AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.06, RELATING TO PARKING, STANDING AND LOADING ZONES AND ADDING SECTION 86.09.05, PROHIBITING PARKING IN STREET SWEEPING ZONES DURING POSTED TIMES - AUTHORITY

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 6, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 86.06 to read as follows:

SEC. 86.06 PARKING, STANDING, LOADING ZONES, STREET SWEEPING ZONES

The City Manager is hereby authorized to determine the location of Loading Zones, Passenger Loading Zones, Bus Loading Zones, Taxi Zones, prohibited Standing or Parking Zones, Safety Zones, Disabled Persons Parking Zones, Alley Parking Zones, Consular Parking Zones, and Street Sweeping Zones. Such zones shall be effective when appropriate signs or curb markings giving notice thereof are erected upon such zones.

Section 2. That Chapter VIII, Article 6, of the San Diego Municipal Code is hereby amended by adding Section 86.09.05 to read as follows:

SEC. 86.09.05 PARKING OR STANDING IN DESIGNATED  
STREET SWEEPING ZONES AT CERTAIN  
POSTED TIMES


No person shall park or stand any vehicle in a designated "Street Sweeping Zone", established pursuant to San Diego Municipal Code Section 86.06 and Section 22507.6 of the California Vehicle Code.

Street Sweeping Zones shall be operative during days and times determined by the City Manager. The operative days and times shall be posted on the appropriate signs erected pursuant to Section 86.06.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.08, RELATING TO PARKING, STANDING AND LOADING ZONES AND ADDING SECTION 86.09.05, PROHIBITING PARKING IN STREET SWEEPING ZONES DURING POSTED TIMES - AUTHORITY

The City Council may, by ordinance, establish and define street sweeping zones pursuant to Section 22507.6 of the California Vehicle Code. Section 22507.6, effective January, 1981, is specific for such street sweeping zones. Prior to 1981, enforcement of prohibited parking in street sweeping areas was pursuant to Section 22507 of the California Vehicle Code, a more general statute, and enforced through San Diego Municipal Code sections 86.08, which established prohibited parking zones, and 86.08(e), which made it unlawful to violate prohibited parking zone signs.

This amendment and addition are necessary to update the Municipal Code to bring it within the more specific authority of Vehicle Code section 22507.6.
