BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 2, Division 7, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 102.0702 to read as follows:

Any person owning real property may request, and the Planning Director shall determine, whether such real property complies with the provisions of this Article and Section 101.0101.34 of the San Diego Municipal Code-Lot Definition. Upon making such a determination, the City shall cause a certificate of compliance to be filed for record with the Recorder of San Diego County. certificate of compliance shall identify the real property and shall state that the division thereof complies with the applicable provisions of this Article and Article 1, Chapter X of this Code. The applicant requesting a certificate of compliance shall submit to the Planning Department adequate legal description, facts and maps which will permit the Planning Director to issue the certificate of compliance in accordance with Chapter 7, Article 2 of the Subdivision Map Act. An applicant shall pay to the

City a reasonable deposit, as approved by the City Council by resolution, to permit the City to recover costs of processing the certificate of compliance. An additional deposit may be required to cover incurred costs. Any deposit in excess of the City's costs will be refunded to the applicant.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
