AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16007-1 AND NO. OO-16007-2, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE CITY ATTORNEY'S DEPARTMENT (045) ONE (1.00) CHIEF DEPUTY CITY ATTORNEY POSITION; TRANSFERRING WITHIN THE GENERAL FUND 100, THE SUM OF \$35,078 FROM THE UNALLOCATED RESERVE (605) TO THE CITY ATTORNEY'S DEPARTMENT (045), FOR THE PURPOSE OF PROVIDING PERSONNEL AND RELATED NON-PERSONNEL FUNDS FOR THE ABOVE POSITION.

WHEREAS, trial calendars in the Litigation Division of the City Attorney's office contain so many cases that it is impossible for one Chief Deputy City Attorney to supervise all assigned deputies properly; and

WHEREAS, in order to narrow the span of supervisorial control and recognize the importance of the litigation effort to the fiscal security of the City, it is recommended that an additional Chief Deputy position be created; and

WHEREAS, the new position would be assigned to the Litigation Division and each Chief Deputy in the Division would supervise approximately half of the City's trial calendar and would report to the Senior Chief Deputy, whose duties would consist solely of supervision of the two Litigation Division Chief Deputies and oversight of the litigation program; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16007 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. 00-16007-1 and No. 00-16007-2, as amended and adopted therein, by adding to the Personnel Authorization of the City Attorney's Department (045) one (1.00) Chief Deputy City Attorney position.

Section 2. That the Auditor and Comptroller is hereby authorized to transfer within the General Fund 100, the sum of \$35,078 from the Unallocated Reserve (605) to the City Attorney's Department (045) for the purpose of providing personnel and related non-personnel funds for the above authorization.

Section 3. This ordinance shall take effect and be in full force on February 13, 1984.
