AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16007-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF COUNCIL DISTRICT 3 (023), ONE (1) COUNCIL REPRESENTATIVE I POSITION; EXEMPTING SAID POSITION FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, Council District 3 has requested the addition of one (1) Council Representative I position to its personnel allocation; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on July 1, 1982, and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, additional funds in the sum of \$18,200 are required to be transferred to Council District 3 so that the requested position may be funded for the remainder of the current fiscal year, funds not having previously been so authorized in the fiscal year budget; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance and transfer the necessary money to effectuate said additional position; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16007-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 023, Councilmanic District 3, one (1) Council Representative I position.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on July 1, 1982, the Council Representative I position is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified position created in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.0 and 7.1 of the Table of Classifications and Standard Salary Rates under Managerial Category A, identified as Exhibit C to Ordinance No. 15976 (New Series), be and the same is hereby adopted.

Section 4. That the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100, the

sum of \$18,200 from the Unallocated Reserve (605) to Council District 3 (023) for the sole and exclusive purpose of defraying personnel and related nonpersonnel expenses.

Section 5. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
