ORDINANCE NUMBER O-16088 (New Series)

AN ORDINANCE AMENDING CHAPTER II, ARTICLE 6 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 26.06 RELATING TO THE SMALL BUSINESS ADVISORY BOARD.

WHEREAS, the Small Business Advisory Board was created by Ordinance No. O-15776 (New Series), on July 7, 1982; and

WHEREAS, said Board was established with seven (7) members, delineated specifically subsection B thereto; and

WHEREAS, it is now desired to amend the membership structure by increasing the Board from seven (7) to nine (9) members, increasing therein by two (2) the membership appointed from the City at large; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 6 of the San Diego Municipal Code be and the same is hereby amended by amending section 26.06 to read as follows:

SEC. 26.06 SMALL BUSINESS ADVISORY BOARD

- A. PURPOSE AND INTENT - No change in this section.
- B. SMALL BUSINESS ADVISORY BOARD ESTABLISHED

There is hereby established a Small Business Advisory Board consisting of nine (9) members who shall serve without compensation. The Board shall include one (1) representative from each of the following groups:

No change in subsections 1 through 4.

The five remaining appointees considered for selection may include, but not limited to, representatives of the following areas of interest and expertise:

- Small business owner;
- Accounting financial-lending, legal or economic backgrounds;
- Advocates of small business interests with governmental agencies;

The members shall serve two (2) year terms and each member shall serve until a successor is duly appointed and confirmed. The members shall be appointed by the Mayor and confirmed by the Council. The members shall be appointed in such manner so that the terms of not more than five (5) members shall expire in any year. The expiration date of all terms shall be July 1. The Board shall select from among its members a Chairperson. The Board shall meet not less than once every three (3) months and present a report to the Mayor and Council on an annual basis. The Mayor shall appoint one member of the Council to serve as liaison to the Board and one other member of the Council as an alternate.

The Board shall adopt rules consistent with laws for the government of its business and procedures.

C. DUTIES AND FUNCTIONS - No change in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage. \
