

ORDINANCE NUMBER O- 16093 (New Series)

Adopted on DEC 12 1983

AN ORDINANCE INCORPORATING ALL OF LOT 3, FAIRMOUNT PLAZA, MAP NO. 3268, (APPROXIMATELY 1.25 ACRES), LOCATED NORTH OF HOME AVENUE BETWEEN GATEWAY AND SPILLMAN DRIVES, IN THE MID-CITY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 35 (NEW SERIES), ADOPTED SEPTEMBER 12, 1932, AND ORDINANCE NO. 6544 (NEW SERIES), ADOPTED JUNE 14, 1955, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Lot 3, Fairmount Plaza, Map No. 3268, (approximately 1.25 acres), located north of Home Avenue between Gateway and Spillman Drives, in the Mid-City Community Plan area, in the City of San Diego, California, within the boundary of the district designated "CA" on Zone Map Drawing No. B-3596.1, filed in the office of the City Clerk as Document No. 768777, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by Section 101.0428.1 of the San Diego Municipal Code.


Section 2. That Ordinance No. 35 (New Series), adopted September 12, 1932, and Ordinance No. 6544 (New Series), adopted June 14, 1955, of the ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the

provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
