AN ORDINANCE AMENDING ORDINANCE NO. O-16007 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16007-1, AS AMENDED AND ADOPTED THEREIN, BY EXEMPTING ONE (1) COUNCIL REPRESENTATIVE I POSITION FROM THE CLASSIFIED SERVICE, PURSUANT TO CHARTER SECTION 117; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, Council District 8 (028) was authorized a Council Representative I position in the fiscal year 1984 budget; and

WHEREAS, that position has not been filled at this time and it is now desired to fill said vacancy; and

WHEREAS, Council District 8 has requested the exemption from the Classified Service of that one (1) Council Representative I position authorized its personnel allocation; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on December 1, 1983 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, the required funds are contained in the Council District 8 budget due to previous authorization; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said additional position and expenditure of funds; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 0-16007 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1983-84 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR " be and the same is hereby amended by amending Document No. 00-16007-1, as adopted and amended therein, by authorizing the expenditure of funds for one (1) Council Representative I position in Council District 8, said position currently authorized as shown in the personnel authorization of Council District 8 (028).

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on December 1, 1983, the Council Representative I position is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3 As a schedule of compensation for the above unclassified position, the salary rate set forth in Salary Rates 7.0 and 7.1 of the Table of Classifications and Standard Salary Rates under Managerial Category A, identified as Exhibit C to Ordinance No. 15976 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

WHEREAS, ORDINANCE NO. O-16094, ENTITLED "AN ORDINANCE AUTHORIZING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1984 AND APPROPRIATING THE NECESSARY FUNDS TO OPERATE THE CITY OF SAN DIEGO FOR THE FISCAL YEAR," BY AMENDING DOCUMENT NO. 100000, AS AMENDED AND ADOPTED BY THE COUNCIL OF THE CITY OF SAN DIEGO, IS AMENDING ONE (1) COUNCIL REPRESENTATIVE POSITION FROM THE CLASSIFIED SERVICE POSITION TO CHARTER SECTION 117; AND AUTHORIZING A SALARY RATE THEREFOR.

IT IS HEREBY ORDERED that the annual budget by exempting one (1) Council Representative position from the classified service position and authorizing a position in the personnel authorization system, Series 9. No additional funds are required to be expended for the position. This is not an additionally authorized position as it is included in the current budget; this action is solely for expenditure purposes to Charter section 117 and authorization of personnel expenditures.
