Section 1. That Chapter VIII, Article 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 86.23 to read as follows:

SEC. 86.23 Use of Streets For Storage, Service or Sale Of Vehicles or For Habitation Prohibited

- (a) through (h) [No changes.]
- (i) No person shall park a trailer upon any street except for the purpose of loading or unloading.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
