AN ORDINANCE AMENDING CHAPTER VIII,

BE IT ORDAINED, by the Council of The City of San Diego, as
follows:

Section 1. That Chapter VIII, Article 6, of the San Diego
Municipal Code be and the same is hereby amended by amending
Section 86.23 to read as follows:

**SEC. 86.23 Use of Streets For Storage, Service or
Sale Of Vehicles or For Habitation
Prohibited**


(a) through (h) [No changes.]

(i) No person shall park a trailer upon any
