

That the bids of 1. CONTRACTOR SUPPLY and 2. U. S. INDUSTRIES SUPPLY are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of CHECK VALVES as follows:

1. CONTRACTOR SUPPLY - for Item 1, 1-inch check valves, at a cost of \$65.75 each, for a total cost of \$6,575.00; terms net, plus sales tax.
2. U. S. INDUSTRIES SUPPLY - for Item 2, 2-inch check valves, at a cost of \$126.06 each, for a total cost of \$12,606.00; terms 2% 30 days, plus sales tax.
