
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of BETTY ANN SINER, as Trustee of the Trust under the will of Henry Siner, deceased, executed in favor of The City of San Diego, bearing date of August 2, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 257710, granting to said City an easement for public street purposes in a portion of Pueblo Lot 1110, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named CAMINO DEL RIO SOUTH.
