

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a First Amendment to lease agreement between City and BARRIO STATION, INC., a private nonprofit corporation, which Amendment adds the property at the northwesterly corner of Newton Avenue and Sampson Street in the Barrio Logan area to the area presently leased to Barrio Station, Inc. pursuant to that lease on file in the office of the City Clerk as Document No. 767679, and which Amendment further requires the construction and operation of a community swimming pool and extends the term of the original lease from ten (10) years to thirty-five (35) years, under the terms and conditions set forth in that First Amendment to lease agreement on file in the office of the City Clerk as Document No. RR- 257722.
