RESOLUTION NUMBER R- 257724

WHEREAS, JOHN E. HAUGH and MARIA D. HAUGH, husband and wife, have requested an exchange of drainage easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of JOHN E. HAUGH and MARIA D. HAUGH, husband and wife, executed in favor of The City of San Diego, bearing date of December 3, 1982, conveying to said City a drainage easement in a portion of Lot A195 in Addition 2 to San Ysidro, Map 1246, as more

particularly described in said deed, is hereby approved. On file in the City Clerk's Office as Document No.


2. That the Mayor and City Clerk of said City be, and RR 257724-1 they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 257724-2, quitclaiming to JOHN E. HAUGH and MARIA D. HAUGH, husband and wife, all of the City's right, title and interest in the drainage easement in portions of Lots A195 and A196 of Addition 2 to San Ysidro, Map 1246, as more particularly described in said deed.

3. That the City Clerk is hereby authorized and directed to deliver both deeds, and a certified copy of this resolution to the Property Department for further handling.
