RESOLUTION NUMBER R- 257731

Adopted on JAN 3 1983

WHEREAS, on May 11, 1982, the County of San Diego Board of Supervisors approved a grant with the Office of Criminal Justice Planning (OCJP) for establishment of a gang prosecution unit within the District Attorney's office; and

WHEREAS, this approved grant called for the hiring and assignment of a temporary investigator to assist this unit; and

WHEREAS, the District Attorney's office now wishes to enter into a contract with the City of San Diego for the assistance of one (1) police officer for a nine (9) month period to be assigned to the Gang Prosecution effort to work as a district attorney investigator within the Gang Prosecution Unit; and

WHEREAS, The City of San Diego shall be fully reimbursed for all costs of the police officer, including salaries and fringe benefits; and

WHEREAS, both the District Attorney's office and the San Diego Police Department will benefit by the knowledge gained through this closer working relationship; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered, for and on behalf of said City, to execute an agreement with the County of San Diego for the purpose of providing fully reimbursed services of one police officer to work with the District Attorney's office Street Gang Unit, for a

nine-month period ending May 31, 1983, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR-257731.
