BE IT RESOLVED, by the Council of The City of San Diego, as follows:



That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the County of San Diego for the installation of a temporary traffic signal and safety lighting system at the intersection of Woodman Street and South Bay Freeway, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 257732.

2. That the transfer of \$10,000 from Capital Outlay Fund 30245, CIP 68-001, "Cooperative Projects to CIP 52-110.2, "Beyer Boulevard-Route 117 to North City Limit" is hereby authorized.

3. That the transfer of \$10,000 from Gas Tax Fund 30219, CIP 52-110.2, "Beyer Boulevard Route 117 to North City Limit" to CIP 68-001, "Cooperative Projects" is hereby authorized.

4. That the expenditure in the sum of \$10,000 from Gas Tax Fund 30219, CIP 68-001, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
