BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to do by City Forces all the work to install street lighting systems on Hemingway Avenue north of Cibola Road; Black Mountain Road and Hillery Drive, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$7,500.00.

BE IT FURTHER RESOLVED, that the sum of \$7,500 from Capital Outlay Fund 30245, CIP 52-293, "Installation of City-owned Street Lights," for the purpose of executing this work and related costs is hereby authorized.
