

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. NIXON-EGLI EQUIPMENT COMPANY, 2. DENAIR TRAILER COMPANY, and 3. VERMEER CALIFORNIA are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SIX (6) EQUIPMENT HAULING TRAILERS as follows:

- 1. NIXON-EGLI EQUIPMENT COMPANY for Item 1 three (3) each, 12,000 lb. capacity tilt bed trailers, at a cost of \$4,333.00 each, for a total cost of \$12,999.00; and Item 3 one (1) each, 32,000 GVW tilt bed trailer, at a cost of \$9,441.00, for a total cost of \$22,440.00; terms net 15 days, plus sales tax.
- 2. DENAIR TRAILER COMPANY for Item 2 one (1) each, 22,300 GVW tilt bed trailer, at a cost of \$10,065.00; terms net 20 days, plus sales tax.
- 3. <u>VERMEER CALIFORNIA</u> for <u>Item 4</u> one (1) each, 32,000 GVW tilt bed semitrailer, at a cost of \$10,199.00; terms net 30 days, plus sales tax.
