

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

CONSTRUCTION OF SORRENTO VALLEY BIKEWAY GENESEE AVENUE TO CITY OF DEL MAR.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$93,500.00 from Local Transportation Fund 39005; and not to exceed \$78,000.00 from Capital Outlay Fund 30245, CIP No. 58-015.2, SORRENTO VALLEY BIKEWAY - PHASE II of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
