
RESOLUTION NUMBER R- 257767

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Bement-Dainwood-Sturgeon, Inc. for design consultant services in connectin with the improvement of alleys and replacement of utilities in the City Heights and Logan Heights Community Development Block Grant area, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 257767.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$37,980 from Fund 18518 for alley Improvements and \$9,220 from Fund 41506 and \$1,700 from Fund 41502 for sewer and water main replacement respectively, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
