BE IT FURTHER RESOLVED, that the expenditure of \$12,521 for the above purpose and related costs is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to proceed with Task Order No. 15, Amendment No. 1 of the agreement with CH2M HILL, et al, a joint venture, in connection with the Point Loma Accelerated Projects for the sum of \$12,521.
