WHEREAS, said notice has been given by posting the intention to increase said charges by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to Section 67.59 of the San Diego Municipal Code the following monthly fire service and automatic fire sprinkler service charges are established:
