RESOLUTION NUMBER R- 257779

Adopted on JAN 10 1983

WHEREAS, Section 67.72 of the San Diego Municipal Code provides that minimum water capacity charges may be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice has been given by posting the intention to increase said charges by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That pursuant to Section 67.72 of the San Diego Municipal Code, the following minimum water capacity charges are established:

A minimum capacity charge of Two Hundred Ninety Dollars (\$290.00) per single family unit or equivalent shall be paid.

In those areas of the City where a capacity charge in the form of area charges as established by Council resolutions, or taxation, or special assessment districts excluding 1911 and 1913 Act assessment districts, results in a payment to the City totaling more than Two Hundred Ninety Dollars (\$290.00) per single family unit or its equivalent, no new capacity charge shall be imposed by this section. However, charges imposed due to reimbursable agreements entered into by the City shall be collected where applicable in every case.

The maximum capacity charge that shall be collected for any one single connection or manifolded multiple metered connection shall be Five Thousand Dollars (\$5,000.00) regardless of the number of equivalent family units. The Five Thousand Dollars (\$5,000.00) maximum shall include capacity charges, area charges or the value of existing capacity in equivalent family units paid, acquired or being used prior to the adoption of this resolution.
