WHEREAS, Section 67.58 of the San Diego Municipal Code provides that Fire Hydrant service rates shall be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice has been given by posting the intention to increase said charges by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to Section 67.58 of the San Diego Municipal Code the following Fire Hydrant Service charges within the City are established:

FLAT RATE

For each such fire hydrant located  
on City property \$6.00 per annum

When the private property owner  
contracts with City for fire  
hydrant maintenance, for each  
such fire hydrant located on  
such private property 42.00 per annum
