

That the bid of AZTEC LANDSCAPE CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF RANCHO BERNARDO PARK AND RECREATION CENTER as may be required for a period of twelve (12) months beginning February 1, 1983 through January 31, 1984 for a cost of \$29,761.50; terms 5% 20 days, with options to renew contract for two (2) additional twelve (12) month periods at prices not to exceed 12% of bid price.
