RESOLUTION NUMBER R- 257790

Adopted on JAN 17 1983

WHEREAS, the City of San Diego is proceeding with redevelopment in the Marina Columbia, and Horton Plaza areas of downtown; and

WHEREAS, the redevelopment of these areas will impact several nearby City streets with an increase in traffic density; and

WHEREAS, the City Manager has recommended that several streets in the downtown area be converted from one-way to two-way operation; and

WHEREAS, the conversion of Second Avenue between "G" Street and Island Avenue, Third Avenue from 150 feet north of "G" Street to Market Street, and "F" Street between First Avenue and State Street to two-way streets would be consistent with the Preferred Street System for Centre City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Second Avenue between "G" Street and Island Avenue is a two-way street.
2. That Third Avenue from 150 feet north of "G" Street to Market Street is a two-way street.
3. That "F" Street between First Avenue and State Street is a two-way street.
4. That installation of appropriate signs and markings is authorized.

5. That this change shall be effective when such signs and markings have been installed.
