

RESOLUTION NUMBER R- 257799

Adopted on JAN 17 1983

WHEREAS, Section 8330, et seq. of The Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution; and

WHEREAS, that portion reserved for future street in Lot 6, Block 50, Linda Vista Subdivision Unit 8, Map 3253, is no longer needed for present or prospective public use; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that portion reserved for future street in Lot 6, Block 50, of Linda Vista Subdivision Unit 8, Map 3253, as more particularly shown on Drawing No. 15467-B on file in the office of the City Clerk as Document No. RR-257799, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the ten foot setback line adjacent to that portion reserved for future street in Lot 6, Block 50, of Linda Vista Subdivision Unit 8, Map 3253, as more particularly shown on Drawing No. 15467-B, on file in the office of the City Clerk as Document No. RR-257799, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered abandoned.

3. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

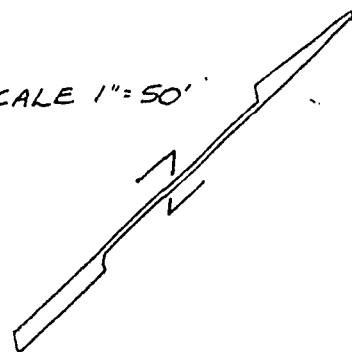

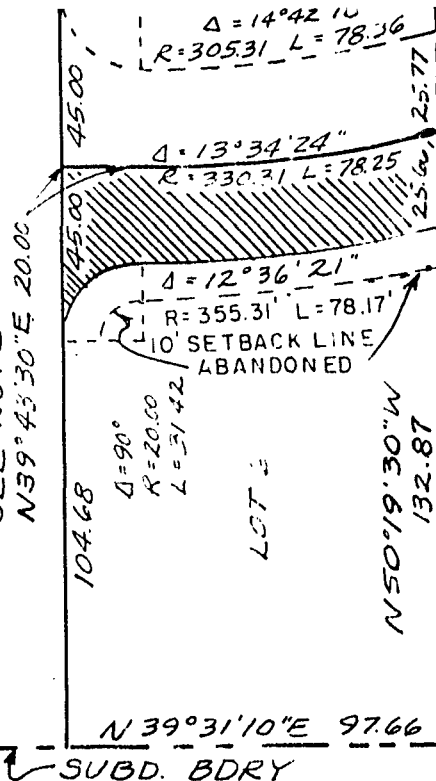
