BE IT RESOLVED, by the Council of The City of San Diego, as follows:



BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to consolidate CIP No. 23-823, Ocean Boulevard Improvements, and CIP No. 23-606, Beach Comfort Station, into CIP No. 23-823, Ocean Boulevard Improvements.

BE IT FURTHER RESOLVED, that the revision of the scope of CIP No. 23-823, Ocean Boulevard Improvements, to include the design and construction of the comfort station, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$80,000 from CIP No. 23-823, Ocean Boulevard Improvements, solely and exclusively for the above purpose, is hereby authorized and approved.
