RESOLUTION NUMBER R- 257839

Adopted on JAN 24 1983

WHEREAS, Route 56 is part of the California Freeway and Expressway System established by the Legislature in 1959; and

WHEREAS, Route 56 is shown in the City's General Plan and Progress Guide between Interstate 5 in Sorrento Valley on Route 67 near Poway; and

WHEREAS, the route location for freeway Route 56 was adopted by CALTRANS on February 15, 1965; and

WHEREAS, completion of Route 56 from Interstate 5 to County Route SA680 has been shown as one of the region's priorities by the year 2000; and

WHEREAS the 1980 Regional Transportation Plan of the San Diego Association of Governments includes Route 56 as a freeway and expressway needed by the year 2000; and

WHEREAS, there is broad-based community support for the construction of Route 56, as determined by CALTRANS studies; and


WHEREAS, Route 56 is the only state highway in the twenty-four mile wide east-west corridor bounded by existing Freeway 78 on the north and the planned Route 52 freeway on the south; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the California Transportation Commission is requested to abandon all efforts leading to the proposed rescinding of an

adopted location for the Route 56 freeway between Interstate 5
and County Road 680, and from Route 125 to Route 67.
