BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that easement deed of WIMPEY/GENTRY, a California general partnership, executed in favor of The City of San Diego, bearing date of November 7, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 257843, granting to said City easements for public street purposes over, along and across portions of Lot 3 and portions of Carroll Road and Brown Deer Road vacated in El Camino Industrial Park Subdivision, Map 10483, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named BROWN DEER ROAD and CARROLL ROAD.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
