John L. Brewer	Fire	\$1,010	Mr. Brewer is a Fire Captain. He suggested the conversion and refurbishing of the American La France fire apparatus. This is expected to save \$3,373 in the first year in replacement costs.
Danny L. Lenz	General Services	\$1,000	Mr. Lenz is a Painter Supervisor in the Buildings Division. One year ago he earned a partial award of a Certificate of Merit for his suggestion to purchase a high pressure cleaning machine for use on graffiti. One year's experience has shown a savings of \$13,935. This is the remainder of his award.
Larry Wasserman	Water Utilities	\$500	Mr. Wasserman is an Assistant Chemist in the Metro Wastewater Division. He suggested connecting the gas partitioner to the gas chromatography data station to analyze digester gases. This is expected to save \$3,058 in the first year in labor costs.
