<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Albert D. Johnson	General Services	\$450	Mr. Johnson is a Senior Building Maintenance Supervisor in the Buildings Division. One year ago he earned a partial award of \$455 for his suggestion to purchase compact trucks and camper shells. One year's experience has shown a savings of \$9,048. This is the remainder of his award.
Vincent De Leva	General Services	\$310	Mr. De Leva is an Electrical Supervisor in the Communications and Electrical Division. He suggested reducing the wattage of the metal halide street lights around City College. This is expected to save \$2,055 in the first year in energy costs. This is a partial award pending a final 12-month review.
Bruce G. Brown Jim Toci	City Council General Services	\$255	Mr. Brown was a Council Representative and Mr. Toci is an Assistant Electrical Engineer in the Communication and Electrical Division. They suggested disconnecting unnecessary traffic signal heads on one-way streets in the downtown area. This is expected to save \$1,676 in the first year in time, material and equipment costs. This is a partial award pending a final 12-month review.
