Willie C. Shipley Jesus Ann Wilson	General Services	\$160	Mr. Shipley was a Principal Supervisor at the time of this suggestion and Ms. Wilson is a Sanitation Driver II in the Solid Waste Division. They suggested the purchase of a wet weather glove for collection personnel. This is expected to save \$1,056 in the first year in material costs. This is a partial award pending a final 12-month review.
Cathy L. Koivisto	Planning	\$ 60	Ms. Koivisto is a Senior Zoning Representative. One year ago she earned a partial award of \$175 for her suggestion to establish a fee for garage conversion permits. One year's experience has shown a revenue of \$780. This is the remainder of her award.
Kenneth W. Roberts	General Services	\$ 50	Mr. Roberts is a Communications Technician in the Communications and Electrical Division. He suggested the design of a ramp for loading heavy equipment on to a pick-up truck. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Willie C. Shipley	General Services	\$ 50	Mr. Shipley was a Principal Supervisor at the time of this suggestion in the Solid Waste Division. He suggested purchasing a different kind of rain suit for collection personnel. Although savings were difficult to estimate, this was considered to be a significant safety improvement. This is a partial award pending a final 12-month review.
