

RESOLUTION NO. R-257851Adopted on JAN 25 1983

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Elbert L. Burnett Jr. Dennis P. Pascale	Fire	\$ 50	Mr. Burnett and Mr. Pascale are firefighters. They suggested equipping fire apparatuses with stop/slow signs. Although savings were difficult to calculate, this was considered to be a significant safety improvement.
Joe A. Pirronello	Fire	\$ 45	Mr. Pirronello is a Fire Captain. He suggested cutting discarded inner tubes into strips for use as hose bindings. This is expected to save \$150 in the first year in material costs.
Robert F. Hutchison	Park & Recreation	\$ 30	Mr. Hutchison is a Ground Maintenance Worker II in the Coastal Division. One year ago he earned a partial award of \$35 for his suggestion to place steel barrels at Ocean Beach Pier for use as trash receptacles. One year's experience has shown a savings of \$223. This is the remainder of his award.
John C. Petersen	Fire	\$ 25	Mr. Petersen is an Equipment Mechanic. He suggested the use of color-coded stickers to identify vehicles due for oil change or annual inspection. Although savings were difficult to identify, this was considered to be a significant operational improvement.
