David A. Buck	Fire	\$ 25	Mr. Buck is a Fire Captain. He suggested the use of intake relief valves to aid in safety of firefighters. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Richard H. Salle	Fire	\$ 25	Mr. Salle is a Fire Captain. He suggested the refilling of apparatus water tanks from fire hydrants. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Herbert M. Yaklin	Park & Recreation	\$ 25	Mr. Yaklin is a Ground Maintenance Worker II in the Central Division. He suggested the installation of step ladders to the sides of truck #5346. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
