BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of VAN WATERS & ROGERS DIV. OF UNIVAR CORP. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing AMMONIUM SULFATE as may be required for a period of one (1) year beginning March 1, 1983 through February 29, 1984, at a cost of \$0.0552 per lb. (\$110.40 per ton) for a total estimated cost of \$30,360.00; terms net 10th prox. with an escalation during the contract year not to exceed 8% of bid price, plus an estimated freight charge of \$481.25; with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 10% of price in effect at the end of the initial year.
