APPROVING MAP OF RESUBDIVISION OF DEL CERRO SHORES UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Gary L. McCabe, a registered Civil Engineer, entitled "RESUBDIVISION OF DEL CERRO SHORES UNIT NO. 1, being a subdivision of Lots 1 through 47, inclusive; Lots 49 through 60, inclusive, and Lots 63 through 82, inclusive, of Del Cerro Shores Unit No. 1, Map No. 9704, and Parcel 3 of Parcel Map No. 12136, and all of Parcel Map No. 11970, all in the City of San Diego, County of San Diego, State of California, all on file in the office of the County Registrar, together with Elmhurst Drive, Edinburgh Court, Ciudad Leon Court, Tema Street (formerly Yokohama Street), Yokohama Court (formerly Tema Court), Cavite Court (formerly Cavite City Court), and Del Cerro Boulevard (a portion thereof formerly Park Ridge Boulevard), all as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities,


as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
