- 4. Cavite City Court, is renamed Cavite Court,

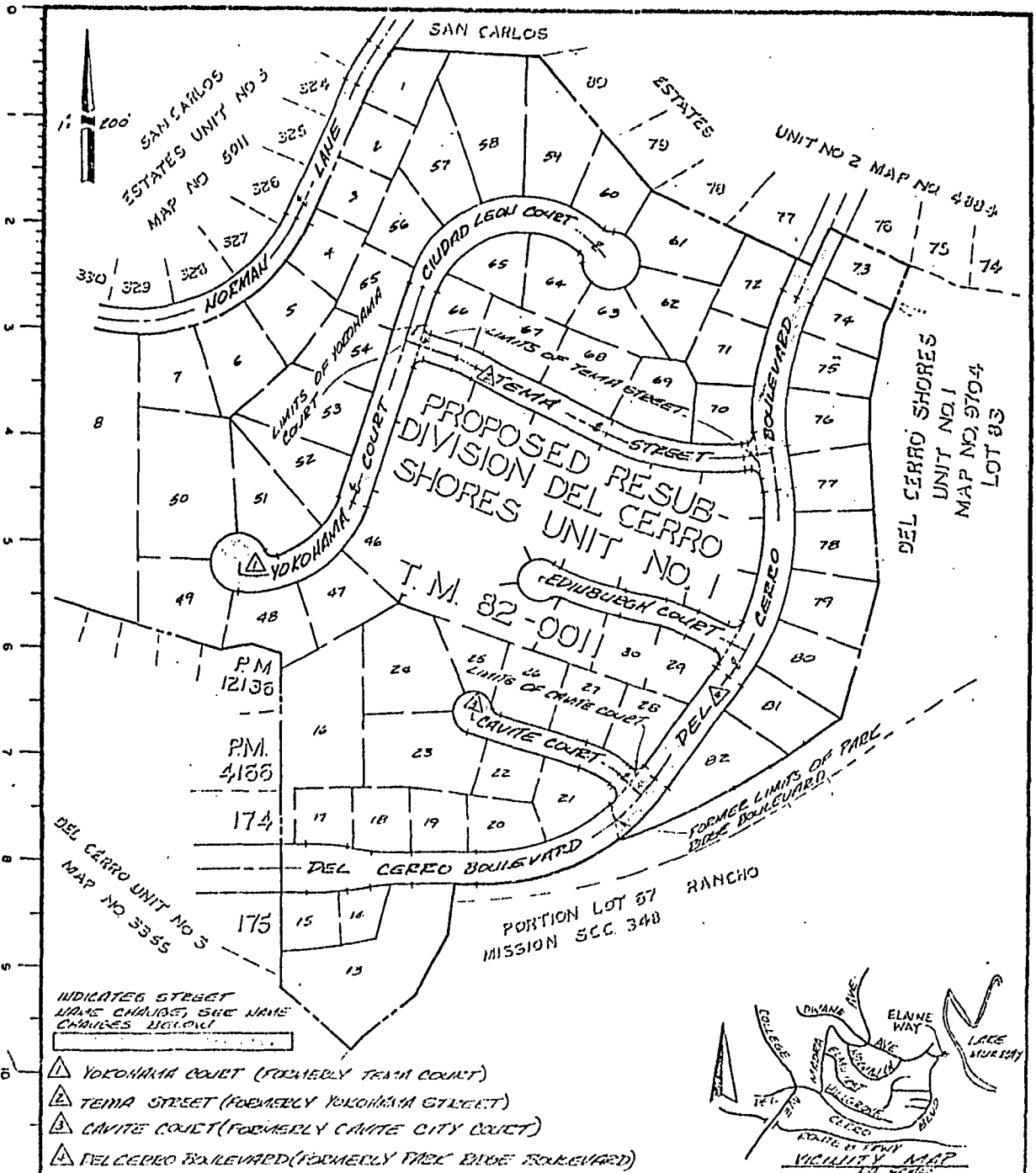

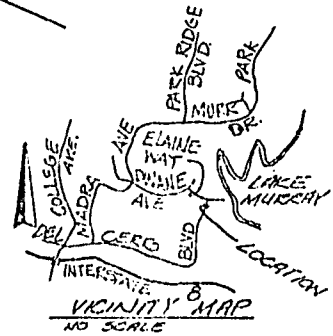
