BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY, a corporation, executed in favor of The City of San Diego, bearing date of September 2, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No.

RR- 257879, granting to said City an easement for public street purposes in a portion of Lots 25 and 26 of Block 49 of Mannasse and Schiller Addition, Map No. 209, located at the intersection of Crosby Street and Harbor Drive, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named CROSBY STREET.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$1,950 from Capital Outlay Fund 30245, CIP 39-004, Miscellaneous Parcels for Right-of-Way, Open Space and Other Public Purposes, for the above acquisition, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is authorized and directed to deliver the deed and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.


