WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Black Mountain Road and Ossuna Canon Road, all within the Black Mountain Glen Subdivision Map (TM 02-134) boundaries, as more particularly shown on Drawing No. 20665-D on file in the

office of the City Clerk as Document No. RR 2578R3, which is by this reference incorporated herein and made a part hereof, be and the same are hereby vacated.

- 2. That the resolution shall not become effective unless and until the final subdivision map for Black Mountain Glen Subdivison Map (TM 02-134) has been approved by Council action. In the event that the final map is not approved by March 22, 1987, this resolution shall become void and be of no further effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.



VICINITY MAP




