RESOLUTION NUMBER R- 257887

Adopted on JAN 31 1983

WHEREAS, in light of the severe unemployment problems within The City of San Diego, a positive approach to job development must be explored; and

WHEREAS, the establishment of a Job Development Task Force is proposed for the purpose and with the responsibility of reviewing current and historical job-producing and job-maintenance approaches; and

WHEREAS, it is envisioned that said Task Force will be comprised of representatives of a cross-section of the job-producing and other affected sectors of the City; and

WHEREAS, the Task Force and its assigned responsibilities are presently conceptual in nature and additional study will be conducted internally for recommendation to the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the concept of a Job Development Task Force be and the same is hereby approved.

2. That William Sage, Chief of Staff to the Deputy Mayor is hereby appointed to chair the Job Development Task Force composed of the City Manager, City Attorney, City Auditor and Comptroller and Director of Intergovernmental Relations for the


purpose of promulgating a membership of interested and affected community organizations to include, but not necessarily be limited to:
