BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$43,000.00 from CIP No. 58-004, MISCELLANEOUS IMPROVEMENTS ON CITY STREETS, Annual Allocation to CIP No. 62-227, TORREY PINES ROAD FROM ARDATH LANE TO GLENBROOK WAY/DUNAWAY DRIVE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$188,000.00 from Capital Outlay Fund 30245, CIP No. 62-227, TORREY PINES ROAD FROM ARDATH LANE TO GLENBROOK WAY/DUNAWAY DRIVE of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
