

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add CIP No. 23-157.1, UNIVERSITY VILLAGE NEIGHBORHOOD PARK - Sidewalk Improvements to the FY 1983 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$6,200.00 from CIP No. 20-001, MINOR IMPROVEMENTS, Annual Allocation to CIP No. 23-157.1, UNIVERSITY VILLAGE NEIGHBORHOOD PARK - Sidewalk Improvements.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$6,200.00 from Capital Outlay Fund 30245, CIP No. 23-157.1, UNIVERSITY VILLAGE NEIGHBORHOOD PARK - Sidewalk Improvements of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
