

RESOLUTION NUMBER R- 257908

Adopted on FEB 7 1983

WHEREAS, on November 10, 1982, the San Diego County Board of Supervisors adopted a legislative policy to support adequate staffing by the federal government of the San Ysidro border crossing and the second border crossing on Otay Mesa, which is scheduled to open in March 1984; and

WHEREAS, the Board of Supervisors is seeking support for this legislative policy from those other jurisdictions which are likely to benefit from an expeditious border crossing operation; and

WHEREAS, the City Council has been requested to consider the legislative policy for endorsement and inclusion in the City's legislative program; and

WHEREAS, the legislative policy is contained in the Board of Supervisors Policy No. M-36; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the intent of the County of San Diego's Legislative Policy No. M-36, on file in the office of the City Clerk as Document No. RR-257908, be and the same is hereby supported.

BE IT FURTHER RESOLVED, that the Director of the Intergovernmental Relations Department be, and he is hereby directed to bring forward information and recommendations, as necessary, for Council consideration of including such intent and similar provision in the City's legislative program,

provided however, that in addition to the two named border crossings, there also be included by name, the Virginia Street Commercial crossing.
